

Terms & Conditions for Easter Promo

1. These are the terms and conditions which apply to any competition, discount offer, prize draw, or promotion that our promotion partners or we may run, whether on our or their websites, social media platforms, on-air, or otherwise ('**Promotion**').
2. By entering a Promotion, you agree to be bound by these terms and conditions and any other Specific Rules related to a Promotion. Specific Rules might include entry instructions and any other specific details, rules, or conditions relating to a particular Promotion and might be published on our or our promotion partners' website or social media platforms or may be found in any other media which features a Promotion. The Specific Rules will usually (but may not always) refer to these terms and conditions.
3. In these terms and conditions, '**we,**' **us,**' '**our,**' and '**Promoter**' all mean **Arnergy Solar Limited**. Our registered address is 1 Industrial Avenue, Ilupeju Lagos.

Our '**promotion partners**' are third parties who operate promotions with us or on our behalf; they will be named in the Specific Rules when applicable.

Start and end date/time.

4. The promotion will start on 27th March 2023 and end on 10th April 2023 unless a later start date/time is specified, and this will be made clear in the Specific Rules or the relevant promotional materials. The publicity campaign around the promotion will commence on 13th March 2023 and end on 10th April 2023.

Entering a Promotion

5. 100% full payment must be made within the period of the promo ending 10th April 2023 to qualify for the promo discounts.
6. The Promo is for outright purchases only.

7. All Purchases made before or after the promo dates are not eligible for the promo discounts.
8. Sales through sales agents and solar angels' network are exempted from the promo.
9. Discounts on system purchases invalidate the promo offers.
10. Promo discounts are effected on your payment due for the desired Arnergy Solar system, and the deductions are reflected in the issued invoice.

Other rules

11. If we consider that you or your entry are in breach of these terms and conditions, We reserve the right to disqualify you from a Promotion and/or discounts (without us incurring any liability).
12. We reserve the right to withdraw or amend any Promotion, Specific Rules, and/or these terms and conditions if we consider it necessary or appropriate to do so for reasons beyond our reasonable control or if there has been a broadcasting or printing error, etc. Any changes will be posted here and/or on our website.
13. When entering a Promotion or claiming a discount, you must use your real name. You may be required to provide us with proof of your identity and eligibility on request. Failure to provide adequate information (or to prove eligibility adequately) may result in your disqualification and/or withholding or withdrawal of discount offers.
14. You agree to keep confidential any information that you know or reasonably ought to know confidential and which relates to us, our business, the Promotion, or the discount.
15. In the event of any dispute, our and any judges' decisions are final, and no correspondence will be entered into.

the whole or any part of the terms and conditions or any Specific Rules does not affect the remainder of these terms and conditions or any Specific Rules, which will remain in full force and effect.
